Education:

It is through Education and Outreach that we can raise awareness of our marine environment and the Whales, Dolphins and Porpoises that inhabit them.

You can support our efforts to run workshops and courses on topics like Species Identification and Recording, Live Stranding responder training, and Photo Identification. We also arrange school visits, and the Shannon Dolphin Centre in Kilrush also provides students with the opportunity to see skeletons, hear sounds, and learn about the latest research.

The Floating Classroom is another educational initiative we run aboard IWDG's Research Vessel Celtic Mist, which sails along the coast of Ireland and invites young people to discover more about the marine environment and the cetacean species of Ireland.

With your involvement, we can create a more sustainable, environmentally responsible future through education, inspiration, and conservation.



IWDG AREAS OF SPONSORSHIP

The core work of the IWDG is to deliver our critically important Sighting and Stranding schemes, which monitor the health of cetacean populations in Irish waters.

Research:

We run two monitoring programs, the Shannon Dolphin Project, which monitors for Shannon bottlenose dolphins that live in the Shannon estuary SAC all year round, and the Whale Track Ireland project, that aims to uncover the activities of large baleen whales in Irish waters. The data collected through these schemes is used to assess the health of cetacean populations, document species distribution, and investigate causes of mortality. This information can then be used to inform conservation strategies, such as protecting important habitats, reducing bycatch, and promoting sustainable fisheries.

IWDG's Deep Diving & Rare Species Investigation Program (DDRIP) is a new initiative that studies rare and deep-diving whales and dolphins found washed up in Ireland. By supporting this project, we can gain a deeper understanding of these majestic marine creatures, as well as provide valuable data to the scientific community. Through your support, the DDRIP is able to invest in specialised equipment, provide protective equipment, and cover costs associated with the collection and transportation of carcasses.

IWDG AREAS OF SPONSORSHIP

The Live Stranding Network is a vital part of the IWDG's welfare works. It consists of a network of trained volunteers and experts who respond to reports of live stranded cetaceans along the Irish coastline. These dedicated individuals work tirelessly to assess and assist these animals, with the overarching goal of returning them to their natural habitat whenever possible. The network also plays a crucial role in collecting valuable data on stranded animals, which contributes to scientific research and informs conservation strategies.

Welfare:

Sandy Salmon's story is a powerful example of the impact of our live-stranding network efforts. On the 1st of June, 2012, the IWDG received a report about a live-stranded bottlenose dolphin at Hannon Strand, Co Kerry. The dolphin did not have any signs of major injury and seemed to be in good physical condition, but she was starting to overheat and her breathing rate was decreasing. Responders Joanne O'Brien (IWDG/ATU) and Barry O'Donoghue (NPWS), with the help of locals, used a tractor with a large transport box to successfully return her to the water. She was observed swimming for 10 minutes before disappearing. Later, in September 2012, the same dolphin shocked researchers onboard a dolphin-watching tour boat from Carrigaholt, when she was seen swimming with a newborn calf. As she was heavily pregnant when she became stranded, two lives were saved that day!
